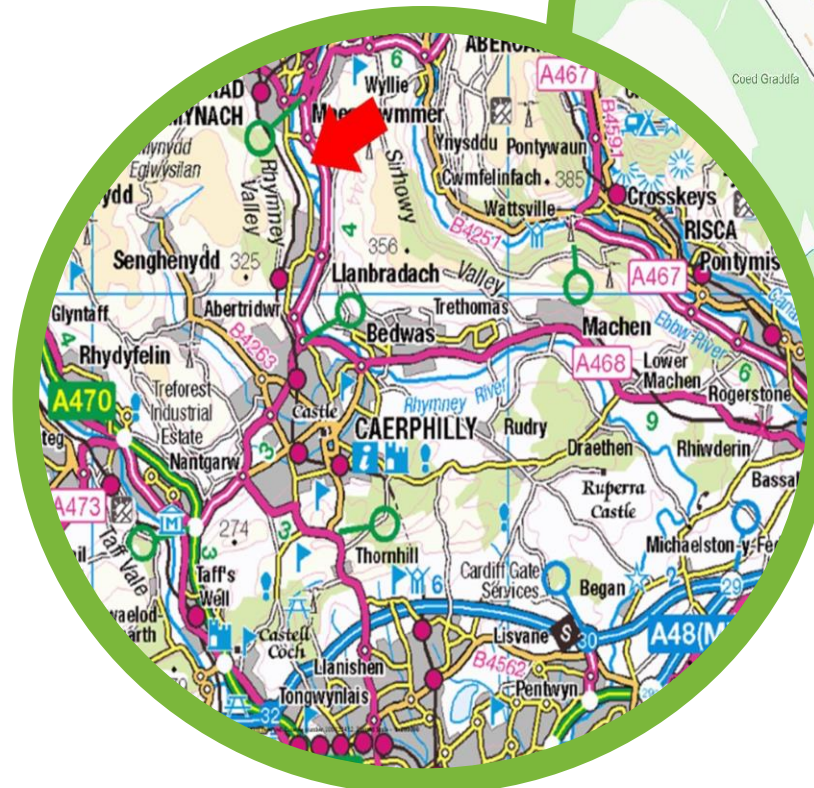

Steel portal frame building with a combination of block work and profiled steel-clad elevations and roof, benefiting from LED strip lighting. Height at roof apex is 4.1metres. Concrete floor.

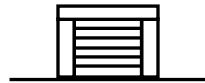

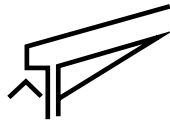
