

THE SPACE

Concordia Works is an award-winning property, set over 5 floors and situated just a short walk from Leeds City Station and the main retail heart of the city. Built in the early 20th Century, this former yarn and cord warehouse has been refurbished with modern businesses in mind, whilst maintaining its existing structure and original period features.

Through the approach of the interior design, the integrity of the warehouse's industrial past has been retained wherever possible. Exposed brickwork, trusses and cast iron columns play a major part in the building's new look. The result is five floors of exceptional and adaptable open plan office space, offering a contemporary working environment for dynamic and creative businesses.



LOCATION



Concordia Works is surrounded by a variety of restaurants, coffee shops and bars which enhance a thriving work environment. With the retail heart of Leeds only a short walk away and a new urban garden adjacent at Sovereign Square this location suits all types.

It has excellent transport links with the property just moments away from Leeds City Station and with the newsouthern entrance completed in 2015, commuting in and out of the city will be even more convenient. The M1 and M621 motorways are only a 5 minute drive away and 2 large multistorey car parks are located 100 yards from the building's front door. For those who prefer a greener mode of travel, riverside cycle paths run close to Concordia Works.
