# LOCATION & COMMUNICATIONS

Purfleet is located in the Borough of Thurrock and sits on the north side of the Thames Estuary, approximately 18 miles (30km) east of Central London and 7 miles (11km) north of Dartford.

The property provides a prime established inner M25 industrial and distribution location, 1 mile north of Dartford, serving Greater London and the South East due to the excellent road communications and proximity to major UK freight terminals.

The property is located on the Purfleet Bypass providing access to Junction 31 of the M25 and the A13, which in turn provide access to Greater London and the wider South East motorway network.

Due to the excellent transport links, the area is popular with a range of national occupiers including Tesco, XPO, Ocado, Amazon, Unilever and DHL.

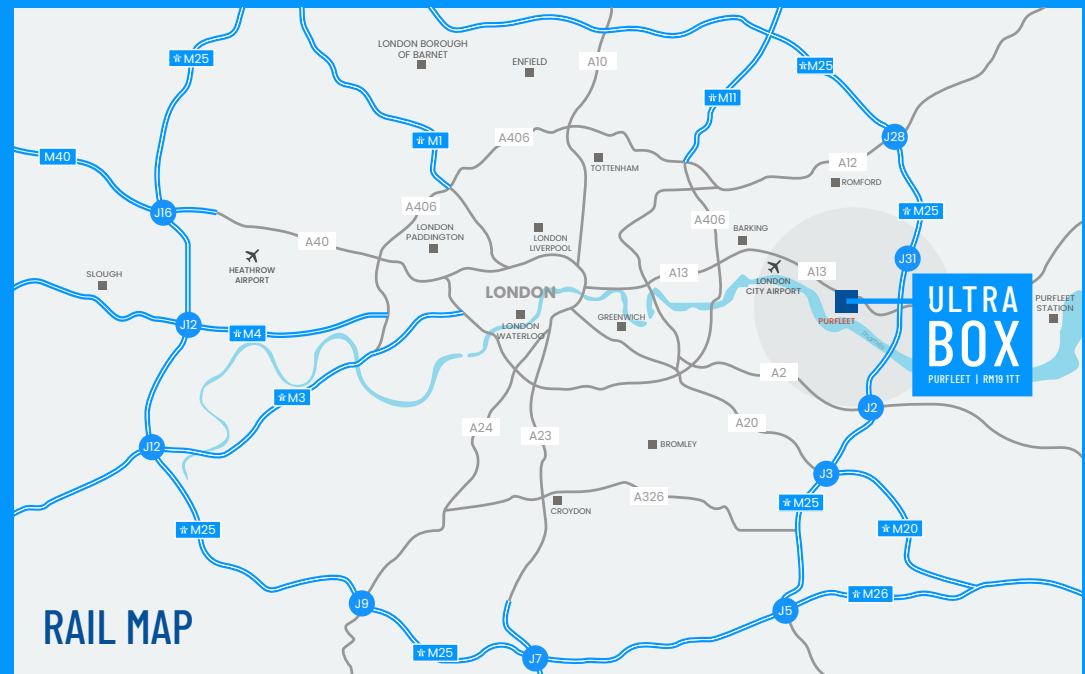
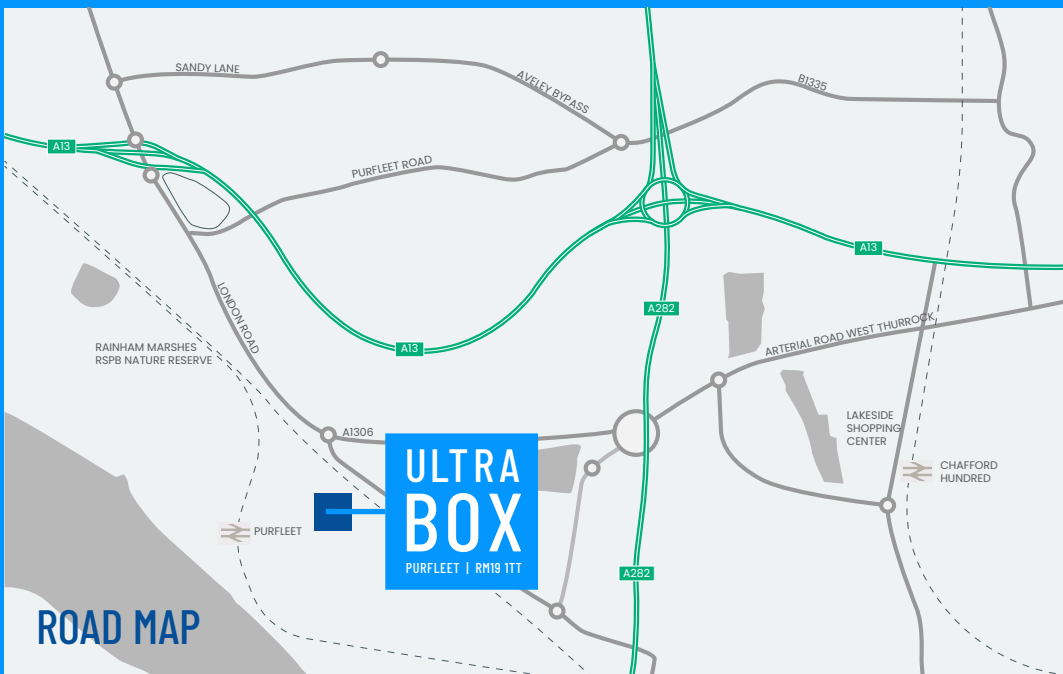
