Description

Crendon Barn, has been sympathetically restored to provide an industrial unit of concrete portal frame construction, new insulated profile metal cladding and roofing system which has been overlaid with timber. Formerly used as an agricultural building, the property has been recently refurbished to a high standard and comprises three phase electric, high speed broadband and a minimum eaves height of 4m rising to 5.8 m to the haunch.

The unit further benefits from 2 electrical roller shutter loading doors. Shared WC's are located nearby the unit.

Crendon Barn is located in a central position within the popular Herriard Estate, approximately 5 miles from Central Basingstoke via the A339. To the south, Alton can be reached by car within 15 minutes.

Nearby occupiers include. 7 Stream Media, Precise Performance Ltd, Sofas & Stuff and Millar Equine Vets.

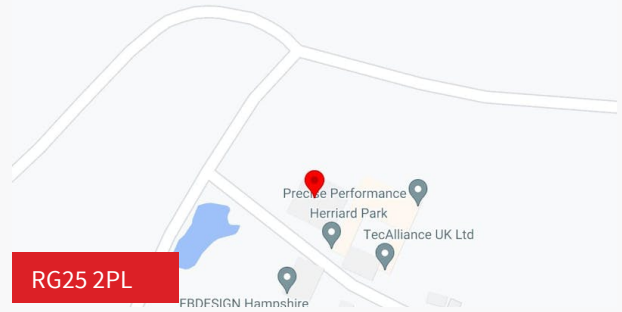
