The property is situated on Quadrant Way, between Weybridge and Bridge Road, in a prominent location near to Weybridge High Street.

Weybridge benefits from excellent road networks with the town being 2 miles from Junction 11 of the M25 at Chertsey and the A3 is 4 miles distant at the Cobham Junction. This in turn gives easy access to the national motorway network and Heathrow and Gatwick Airports.

Weybridge also benefits from a mainline railway station approximately 15 minutes walk away providing a fast and frequent service to London Waterloo.


